Every effort will be made to contact the owner prior to obtaining emergency care.
2. CPS accepts no responsibility for security of the premises or loss if other individuals have access to the home during the term of this agreement. Pet Care will be performed by Cindy or one of her employees. In the event your assigned pet sitter has an emergency, Cindy herself or another qualified individual will resume pet care and you will be notified if someone else does take over the pet sitting job.
3. CPS agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against CPS. Client agrees to notify CPS of any concerns within 24 hours or any complaints regarding service.
4. Customer will be responsible for all medical expenses and damages resulting from an injury to the pet sitter or other persons by the pet. Customer agrees to indemnify and hold harmless CPS in the event of a claim by any person injured by the pet.
5. It is expressly understood that CPS shall not be held responsible for any damage to client's property, or that of others, caused by client's pets during the period in which they are in her care. Client has advised CPS of all situations, which will relieve them of liability for damage. CPS will not be held liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors or dogs on an electric fence as anything can come into the yard and dogs can break the fence if he/she so desires.
6. I agree to allow any CPS employee to take photos of my pet and post them on the happy client's page of the CPS website, place them in my file for reference or use them for any marketing purposes online or in print.
7. Future Services: I authorize this contract to be valid approval for services so as to permit CPS to accept all future telephone, online, mail or email reservations and enter my home without additional signed contracts or written authorizations. I also agree to any future changes CPS might have in rates or service but I will be notified when I book if there are any changes.
